



## GENERAL INFORMATION CLAUSE FOR THE CONSUMER

Pursuant to Article 13(1-2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27/04/2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation - GDPR, Official Journal EU L 119, p. 1), we would like to inform you:

### **I. Personal data Controller:**

The Controller of your personal data is BIOGENED S.A. with its registered office in Łódź, ul. Pojezierska 99, 91-342 Łódź, Company Reg. No. KRS 0000273505.

### **II. Data Protection Officer:**

We have appointed a Data Protection Officer whom you can contact regarding the protection of your personal data via email at the following e-mail address: [iod@biogened.pl](mailto:iod@biogened.pl) or in writing to the address of the Company's registered office.

### **III. Scope of data processed:**

As the Personal Data Controller, we process your personal data provided to us by you in any form (e.g. by phone, e-mail or in the content of the Application Form submitted to us), including: name, surname, contact details, health data and in some cases also the image and bank account number.

### **IV. Purposes and legal basis of processing:**

We have defined the purposes of processing your data. As the Personal Data Controller, we will process your data in order to carry out activities aimed at fulfilling the goals resulting from the legitimate interests of BIOGENED S.A. (legal basis under Article 6(1)(f) of the GDPR), in particular in order to reply to your enquiries regarding our products. The basis for the processing of your personal data is also your consent to the processing of personal data (legal basis under Article 6(1)(a) of the GDPR). If you submit a complaint or claim under the guarantee, we will process your data in order to settle them (legal basis under Article 6 (1) (c) of the GDPR, Articles 577, 580 of the Civil Code).

### **V. Right to object:**

At any time you have the right to object to the processing of your data described above. We will cease processing your data for these purposes, unless we can demonstrate compelling legitimate grounds for our company in relation to your data which override your interests, rights and freedoms, or your data will be necessary for us to determine, exercise or defend any legal claims.

### **VI. Data retention period:**

Your personal data will be retained at the headquarters of BIOGENED S.A. for a period corresponding to the general limitation period for claims.

## **VII. Data recipients:**

Your personal data will be transferred to competent authorities, our advisors, IT, legal, postal or courier service providers.

## **VIII. Rights of data subjects:**

According to the GDPR, you have the following rights

- a) the right of access to your data and obtain a copy thereof;
- b) the right of rectification (correction) your data;
- c) the right of erasure of data, to restriction of data processing;
- d) the right to object to the processing of data;
- e) the right to data portability;
- f) the right to lodge a complaint with the supervisory body - the President of the Data Protection Office (ul. Stawki 2, 00-193 Warsaw);
- g) the right to withdraw consent to the processing of personal data, however the processing of your personal data by Biogened in the period before the consent is withdrawn will be valid and lawful.

## **IX. Information on the requirement or voluntary provision of data:**

Providing your personal data by you is voluntary, but necessary to reply to your enquiry or to implement activities aimed at achieving the goals resulting from the legitimate interests of BIOGENED S.A.

## **X. Automated decision-making:**

Your personal data will not be processed in an automated manner and will not be profiled.
